## Argentina IRAM certification

### General information



This factsheet describes the procedure for preparation, submittal, evaluation, and certification of defined products in the mandatory scope for the certification program.

Resolution No. 508/2015 defined the specific regulatory framework for electrical products. It supersedes and replaces various previous regulations, and unifies them into one regulation. On 5 July 2016, Argentina authority of the compulsory certification scheme for electrical-electronic products decided to make corrections on the Resolution S.C. N°508/2015 to increase efficiency.

With the corrections, a new regulation Resolution S.C. N°171/2016 was issued and came into force on 4 August 2016. This new regulation withdraws and replaces the abovementioned Resolution S.C. N° 508/2015.

Resolution 169/2018 and its supplementary provisions, which are the new version on essential safety requirements for low voltage products using System No. 5(Mark of conformity) or System No. 7(Lot), came into force on May 27th, 2018.
